This matter is before the Court upon the application and request by Victoria Ivashina (the "Applicant") for the extension of a prior exemption, granted by order dated September 17, 2009, from the fees imposed by the Electronic Public Access Fee Schedule adopted by the Judicial Conference of the United States Courts.

The Court finds, based upon the attached letter from the Applicant, dated August 4, 2010, that the Applicant has demonstrated that the extension of the exemption is necessary in order to avoid unreasonable burdens and to promote public access to information.

Accordingly, the Applicant shall be exempt from the payment of fees for access via PACER to the electronic case files maintained in this Court, to the extent such use is incurred in connection with the project described in the attached letter. She shall not be exempt from the payment of fees incurred in connection with other uses of the PACER system in this Court.

Additionally, the following limitations apply:

- 1. This fee exemption applies only to the Applicant, and is valid only for the purposes stated above.
- 2. This fee exemption applies only to the electronic case files of this Court that are available through the PACER system;
- 3. By accepting this exemption, the Applicant agrees not to sell for profit any data obtained as a result of receiving this exemption.
- 4. This exemption is valid from October 2, 2010 through October 1, 2011

This exemption may be revoked at the discretion of the Court at any time. A copy of this Order shall be sent to the PACER Service Center.

I am a finance professor at Harvard Business School and I am conducting academic research on the effects of institutional holdings on Chapter 11 outcomes. 
I believe the issues addressed in this study are at the forefront of bankruptcy scholarship, and I expect this research will eventually have a big impact on research and ongoing policy debates.
