## 2<sup>nd</sup> Annual Bankruptcy Pro Bono Program: From the Courtroom to the Classroom

This CLE Program, featuring two panel presentations, one by Bankruptcy Judges and another by attorneys, will highlight bankruptcy pro bono opportunities available to all practitioners, ranging from fast-paced motion and trial practice to advising high school students about the dangers of credit abuse. Judges from the Southern and Eastern District Bankruptcy Courts will offer perspectives on successful bankruptcy litigation, how it differs from litigation in other courts, and opportunities for pro bono service. The panelists will explore some of the substantive issues arising in pro bono matters, such as student loan discharge, and will discuss the effects of the 2005 Bankruptcy Code amendments on pro bono bankruptcy representations.

The Reception following the panel presentations will honor the Judges of the Southern and Eastern District Bankruptcy Courts and celebrate bankruptcy pro bono activities and volunteers. Information will be provided at the Reception on three separate initiatives: the Bankruptcy Pro Bono Panel (which provides pro bono representation in bankruptcy litigation matters referred by the bench); the Consumer Bankruptcy Project (which advises debt-burdened, low-income individuals on the restructuring of their finances); and the Credit Abuse Resistance Education (CARE) Program (which educates high school students on the thoughtful and responsible use of consumer credit).
