



# Summons Requested

## Request for Subsequent Summons – Attorney Use Only

Step	Action
1	Adversary Notices
2	Enter Adversary Case# Click Next
3	At Select the Party: Choose the party for whom you are filing the request for subsequent summons Click Next
4	At attorney/party association screen: Do Not Uncheck the box Click Next 
5	At Available Events: Select <b>Request for Subsequent Summons</b> Click Next
6	Click Next, again
7	At What type of summons are you requesting? <b>Enter the type</b> in the blank docket text box [1 <sup>st</sup> , 2 <sup>nd</sup> , 3 <sup>rd</sup> , Amended Summons, Second Amended Summons, Third party summons, etcetera] Click Next
